Transfer of the Porsche Registration Number BOX 987

9. The within 14 days of Orders being made herein, the parties shall forthwith take all necessary steps to transfer to the Husband from the Wife, the Porsche motor vehicle with Registration Number BOX 987, including signing all necessary documents in order to effect the transfer.

Superannuation

- 10. Pursuant to section 90MT of the Family Law Act 1975, whenever the Trustee of the Piper Family Superannuation Fund makes a splittable payment from the interest held by the Husband, the Trustee shall pay to the Wife or her administrators, executors, beneficiaries, heirs or assigns, the entitlement calculated in accordance with Part 6 of the Family Law (Superannuation) Regulations 2001, using a base amount of \$64,122.44 and there shall be a corresponding reduction in the entitlement the husband would have had in the Piper Family Superannuation Fund but for this Order.
- 11. Order 10 has effect from the operative time and the operative time is four business days after service of this Order upon the Trustee of the Piper Family Superannuation Fund.
- 12. That the Trustee of the Piper Family Superannuation Fund, in accordance with the obligations set out under the Family Law Act 1975 and the Family Law (Superannuation) Regulations 2001, shall do all such acts and things and sign all such documents as may be necessary to calculate the entitlement of, and make payment to, the Wife in accordance with Order 10.
- 13. That within 30 days of the Wife receiving the superannuation split pursuant to these Orders, the Husband and Wife in their capacity as directors of T. Piper and A. Piper Super Pty Ltd shall do all acts necessary and sign all necessary documents to:

13.1. cause the Wife to resign a director of T. Piper and A. Piper Super Pty Ltd and the husband shall indemnity the wife and keep her indemnified in relation to any

liability for duty, CGT, income tax or any other tax or liability arising as a result of this resignation;

- 13.2. cause the Wife to transfer her shareholdings in T. Piper and A. Piper Super Pty Ltd to the Husband or his nominee and the Husband shall indemnify the Wife and keep her indemnified in relation to any liability for duty, CGT, income tax or any other tax liability arising as a result of this transfer;
- 13.3. if necessary, amend the Trust Deed establishing the fund to ensure that the provisions of this Order are given effect to;
- 14. That the husband shall retain the balance of his interest in the Piper Family Superannuation Fund after the rollover of the Wife's entitlements pursuant to these Orders and the Husband shall be solely responsible for the management and control of the fund following the rollover by the Wife of her superannuation entitlements subsequent to this Order and immediately upon rollover and production by the Husband of necessary documents by the fund a the Husband's sole expense.

General Retention and Responsibility for Liability

- 15. That except as otherwise provided for in these Orders:
 - 15.1. each party shall retain as his or her own property, absolutely all assets and financial resources of whatsoever description, and wheresoever situated of which the party is the legal owner, and/or which is/are in the possession and control of that party as at the date of these Orders;
 - 15.2. the Wife shall be solely responsible for any liability in her name as at the date of these Orders, and shall indemnify and keep indemnified the Husband from all liability arising in relation to same;
 - 15.3. the Husband shall be solely responsible for any liability in his name as at the date of these Orders, and shall indemnify and keep indemnified the Wife from all liability arising in relation to same;
 - 15.4. each party shall be solely liable for, and indemnify the other against all liability encumbering any item of property to which they are entitled pursuant to these Orders;
