The deposit was refunded back into the account. The colonial loan repay was commonwealth bank taking loan repayments out of the wrong account. - 3. You paid the Bond Administrator \$1 780 on 20<sup>th</sup> May 2021 do you have any evidence to support this payment which I can show the auditor?
- 4. You paid Harcourts APG Trust account Single Debit Postings \$1 000 on 16 June 2021 what was this for?
- 5. You paid Colonial Ln repay \$573 what was this for?
- 6. Do you have a Mortgage over this rental if so can I scan me the Mortgage bank Statements please

I hope to prepare some more Minutes for you to sign which basically tells the Auditor everything is "Squeaky clean", you have followed the Act etc and that you appoint him as Auditor of the fund and approved the Financial Statements at the AGM we held at your house recently.





