The Supply Co development continues to progress well. Recent modelling indicates total returns to investors will be in line with those disclosed in the Explanatory Memorandum issued in March 2016. Whilst the total return has been preserved, the IRR has fallen due to the longer time period needed in order to properly execute the investment mandate.

Despite the multiple market headwinds the Project has faced, we have weathered the storms very well. Approximately 92.5% of apartments have been sold with only 10 remaining and we have seen a material pick up in sales interest over the last few weeks which has seen a number sell and a few placed onto reservation.

Construction is progressing well and we have hit the bottom of the basement. The tower crane has been installed and concrete is now beginning to be poured. As such, the building will take shape very quickly from here. To date, we have managed to preserve a large proportion of the construction contingency and we hope that this situation may prevail until completion of construction as this will further enhance returns to investors.

Construction is well underway and the bottom of the basement has been reached. Concrete is now being poured and the superstructure will take shape very quickly.

There are only 10 sales left and Forza Capital is actively marketing these final apartments. We seek to lock away all sales as soon as possible so we can confirm total gross realisation and ultimately, profit.

The construction timeframe is in accordance with expectations. There has been a small time delay with inclement weather and also an issue with a neighbour (which has been resolved). At this stage settlement looks likely in August 2018.
