### Creation of a New Interest

It was noted that a letter from Heather Wilson requesting the creation of a new interest had been received.

#### BY CONSENT IT IS NOTED:

- A. The husband and the wife sold a property at 94 Hayberry Street, Crows Nest ("the Crows Nest property") and vacant land being Lot 591 Maitland Vale Road, Maitland Vale ("the vacant land"). The net proceeds from these sales have been deposited in the name of O'Brien, Connors & Kennett, Solicitors on trust for the husband and the wife with Westpac Banking Corporation BSB No. 032 094 Account no. 242495 and are in the sum of \$775,451.
- B. The husband and the wife are members of the Ross MCL Wilson Superannuation Fund which is a self-managed superannuation fund.
- C. The trustee of the Ross MCL Wilson Superannuation Fund is Ross MCL Wilson Pty Limited of which the husband and the wife are directors.
- D. By the husband and the wife executing these Orders they both each also in their capacity as directors of Ross MCL Wilson Pty Limited hereby confirm that the trustee has notice of these Orders and has no objection to the making of them.

#### BY CONSENT IT IS ORDERED:

- 1. That by way of final property alteration pursuant to Section 79 of Family Law

  Act:
  - 1.1 That pursuant to Section 90 MT(1)(b) of the Family Law Art whenever the trustee of the Ross MCL Wilson Superannuation Fund makes a spiritable payment (whether by way of lump sum or pension) out of the interest held by the husband in the Ross MCL Wilson Superannuation Fund, the wife shall be entitled to be paid 100% of the splittable payment and that there shall be a corresponding reduction in the entitlement of the person to whom the splittable payment would have been made but for these Orders.
