Unanimous Circular Resolution of the members pursuant to section 11 of the Company's Constitution and section 249A of the Corporations Act 2001 (Cth) ("Corporations Act")

Background:	Series B Capital Raise				
	The Company is proposing an equity capital raise of up to AUS\$15,000,000 (the Raise). The fully-diluted pre-money valuation of the Company for the purposes of the Raise is AUS\$56,000,000. As part of the Raise, the Company intends to issue up to 8,125 fully paid Series B Preference Shares at a price per share of AUS\$1,846.04 (Subscription Shares) to various investors including Cool Japan Fund Inc. (CJF).				
	New class of preference share				
	As part of the Raise, the Company intends to create and issue a new class of preference shares entitled 'Series B Preference Shares', ranking senior to all other classes of shares in the Company. The creation and issuance of the new class of Series B Preference Shares will vary the rights of the existing ordinary shares in the Company, which requires the passing of a special resolution or the written consent of holders of at least 75% of the ordinary shares on issue under section 3.3 of the Company's existing constitution.				
	New Constitution				
	To create the new class of Series B Preference Shares, the Company intends to adopt a new constitution, a copy of which is attached as Annexure A (New Constitution). This requires a special resolution of members in accordance with section 136(2) of the Corporations Act.				
	Pre-emptive rights				
	In order to issue the Subscription Shares, the Company would also like the members to waive any rights which they might have in respect of the Subscription Shares, including pursuant to clause 7 of the shareholders' agreement between the Company and the members dated 3 August 2018 (Shareholders' Agreement).				
Variation of Rights:	Resolved, for the purposes of the constitution, the Corporations Act and all other purposes, to approve the variation of the rights attached to the ordinary shares in the Company by the adoption of the New Constitution and the creation and issue of a new class of preference shares, to be called 'Series B Preference Shares' (the terms of which are set out in the New Constitution).				
	By signing this document, the holders of ordinary shares waive their right to any notice required to be given under the Corporations Act or the Company's constitution in respect of the preceding resolution.				
Adoption of New Constitution	Resolved that the constitution of the Company be repealed and replaced with the New Constitution, subject to and with effect immediately prior to Completion (as defined in the subscription agreement to be entered into between the Company and CJF regarding the issue of Subscription Shares to CJF).				
Pre-emption waiver:	Resolved that each member waives any rights in respect of the issue of any Subscription Shares referred to in this document (including, without limitation, any pre-emptive rights or any contractual rights) in its favour whether arising under, or in connection with, (i) any agreement (oral or written) between the Company and its members and relating to the Company, including pursuant to clause 7 of the Shareholders Agreement or (ii) the constitution of the Company from time to time or otherwise.
