Rollover benefits statement for unclaimed superannuation money

Dear Sir/Madam

If you're unable to accept this rollover superannuation benefit payment you will need to complete a *Superannuation payment variation advice* form and return it with the payment on or before 1 August 2023. You will need to include the contributions reference number for that member.

To obtain the payment reference number or to request more information about making a payment, phone **1800 815 886**.

Where any amount is not repaid by the due date, a general interest charge accrues on the outstanding balance until the entire amount has been paid. Interest is calculated on a daily compounding basis and is currently imposed at a rate of 10.90% per annum.

You can claim a general interest charge as a tax deduction in the same financial year that it accrues against your account.
