- 4 Further, the Directors will consider in respect of each investment, the risk to the fund and its member of acquiring it, the diversification of the investment vis a vis all of the other investments owned by the fund, the liquidity requirements of the fund in meeting its liabilities and the effect that this investment will have on those requirements and all matters relating to the prudential nature of the investment after having assessed the entire financial position of the member.
- 5 The Directors will ensure that all the fund's investments are monitored and continue to comply with this strategy and the relevant legislation. The Directors reserve the right to alter this strategy at any time.
- 6 The Directors have considered the death and disability insurance needs of each member and are satisfied that the current covers are appropriate.
- 7 The Directors have reviewed the investment strategy and agree that it continues to satisfy the objectives of the fund.
