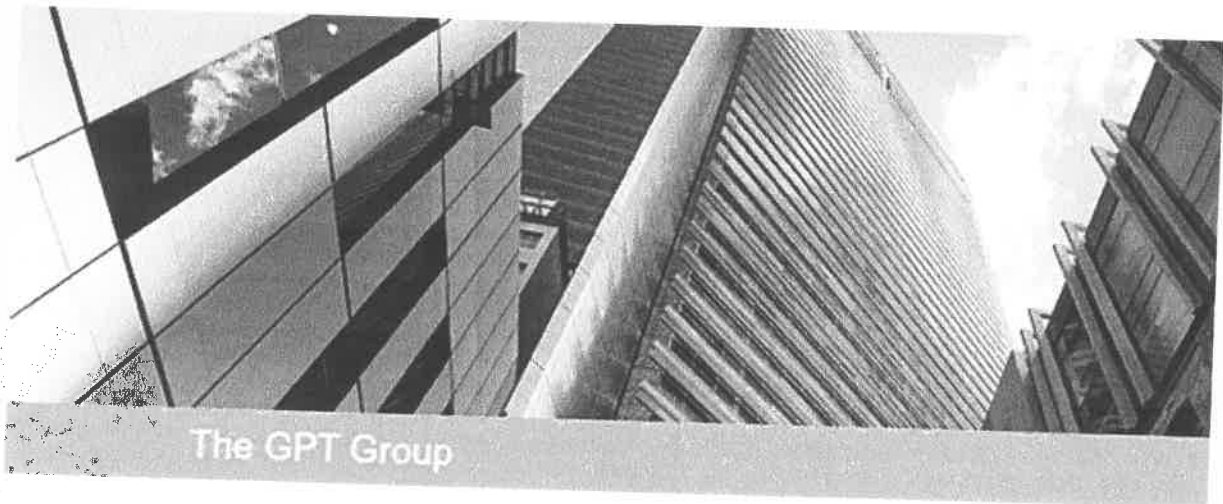

**Opportunity to participate in the GPT Security Purchase Plan**

On behalf of the Board of GPT Group (ASX: GPT) ("GPT"), we are pleased to offer you the opportunity to participate in the GPT Stapled Security Purchase Plan ("SPP") which was announced on Wednesday, 19 June 2019.

GPT recently conducted an institutional placement ("Placement") which raised A\$800 million. The proceeds from the Placement will be used by GPT to fund the acquisition of an interest in Darling Park 1, 2 and Cockle Bay Wharf in Sydney, and provide certainty of funding for GPT to deliver on its strategy to grow its office and logistics portfolios. Any proceeds raised through the SPP will be used initially to reduce debt and provide funds for growth opportunities including GPT's secured development pipeline.
