If payment is being sent by post, please allow time for delivery as interest is payable on overdue instalments.

PENALTY FOR LATE PAYMENT

The Due Date on this notice applies to current charges only. All arrears, previous instalments, interest, legal charges and/or bank fees are due and payable immediately. If you cannot pay your rates and charges by the due date, please contact Council on (02) 9265 9333.

Overdue rates and charges will be actively pursued unless an alternative payment arrangement is agreed. Cost associated with certain action may be recoverable as a debt on the property.

Interest on overdue rates & charges is chargeable on a daily basis at the rate of:

- 6% p.a. for the period of 1 July 2021 - 30 June 2022 inclusive

DOMESTIC WASTE MANAGEMENT CHARGES

Domestic waste management costs include garbage, clean-up and recycling services. Council is required to separately charge for domestic waste management service. The Local Government Act 1993 prohibits these services being financed from ordinary rates and requires the charge be sufficient to recover the reasonable costs of providing the services.

Ratepayers who hold a Pensioner's Concession Card on the date of service of a rate notice are eligible for a rebate in their rates and domestic waste management charges. Application forms will be made available upon request. Where a ratepayer becomes an eligible pensioner during the course of the year, an application for a rebate may be claimed for any full quarterly rating period(s) which remain. If that person's eligibility ceases during the course of the year, the entitlement is taken to cease on the last day of the quarterly instalment period during which that person's eligibility ceases.

DEFERRED RATES AND CHARGES

Eligible pensioners who have previously deferred payment of rates and charges under the policies of the former South Sydney City Council or Leichhardt Municipal Council area may continue to defer payment as allowed under the policies applicable for the year in which the rates and charges were accrued.

RATEABLE VALUE

The land values assigned for rating purposes are supplied to Council by the Valuer General's Department in accordance with legislation. Any objections or appeals regarding the valuation of the land value must be directed to the Valuer General's Office. Whether or not an objection is pending, the rates levied must be paid by the due date.

CATEGORISATION OF LAND

* Declaration of Rating Category of land - S520 of LGA 1993

The rating category of your land is shown on the Annual Rate Notice. If this category changes, you must notify Council within thirty (30) days.

* Application for change of category - S525 of LGA 1993

Application on the prescribed form may be made to Council at any time for a review of the category in which your land has been placed.

* Appeal against declaration of category - S526 of LGA 1993

Appeals may be made to the Land and Environment Court within thirty (30) days of a declaration of land category.

APPEALS

Appeals may be made against the levying of the rate on the ground that the land or part of it is not rateable. A property may be non-rateable if it is owned and used in relation to activities carried out by churches, schools, public hospitals, charities or public institutions, as per Sections 555 & 556 of the Local Government Act 1993. Appeals against rates levied must be made within thirty (30) days of the date of service of the notice.
