# Important Information for Ratepayers

## 1. PAYMENT OF RATES (Section 562)

Annual rates and Charges may be paid in one single instalment by 31st August or by quarterly instalments as shown on the notice.

## 2. AGREEMENT FOR PERIODICAL PAYMENT (Section 564)

Council may accept payment of rates and charges in accordance with an agreement made with the ratepayer. If you are experiencing difficulties in paying your rates, please contact Council's revenue staff for assistance.

## 3. INTEREST ON OVERDUE RATES AND CHARGES (Section 566)

Interest accrues on rates and charges that remain unpaid after they become due and payable. The current interest rates is listed in Council's Operational Plan.

## 4. WRITING OFF ACCRUED INTEREST (Section 567)

Council may write off accrued interest under certain circumstances, e.g. experiencing hardship. Please contact Council Revenue staff for assistance.

## 5. LEGAL PROCEEDINGS FOR RECOVERY OF RATES AND CHARGES (Section 712)

Council may commence legal proceedings to recover overdue rates and charges, interest and legal costs. Service of this notice does not annul either any existing payment arrangement for arrears outstanding or continuing legal action for the recovery of rates and charges.

## 6. PENSIONER RATES/CHARGES (Section 577-579)

Ratepayers who are eligible pensioners may be entitled to a rebate for rates & charges. Pensioners who are not currently receiving a rebate can contact Council's Revenue staff for assistance.

## 7. CATEGORISATION OF LAND (Section 514)

Council is required to categorise land into four categories:

- Residential • Business • Farmland • Mining

## 8. NOTICE OF CHANGE OF CATEGORY (Section 524)

A rateable person (or person's agent) must notify Council within 30 days after the person's rateable land changes from one category to another.

## 9. APPEAL AGAINST DECLARATION OF CATEGORY (Section 526)

A ratepayer who is dissatisfied with Council's decision may appeal to the Land & Environment Court within 30 days of the declaration.

## 10. RATEABILITY OF LAND (Sections 554,555, 559 & 574)

All land in Council area is rateable unless it is exempt from rating. These sections detail land that may be entitled to a rates exemption.

## 11. ZONING INFORMATION

Please note your zoning is different to your rate category. For further information regarding your zone and uses that are permissible under the Council's current Local Environment Plan (LEP), please contact Council's Environmental Services Department.

## 12. DOMESTIC WASTE MANAGEMENT CHARGE (Section 496)

Council must make and levy a charge for the provision of Domestic Waste Management Services for each parcel of rateable land for which the service is available.

## 13. LAND VALUATION ENQUIRES OR OBJECTIONS
