



If the amount due remains unpaid after the due date, the arrears along with any accrued penalties may be recovered using council's debt recovery process.

Default in payment

Rates will be overdue if they have not been paid by the quarter due date shown on the front of this notice. After this date, the following additional charges (as per the Local Government Act 1999) will apply:

- a fine of 2% will be immediately added to the amount due; and
- at the end of each month thereafter, interest (at the rate prescribed in the Local Government Act 1999) will be added on any balance (including interest) not then paid.

Postponement of rates - seniors

Ratepayers who hold a state seniors card (or who are eligible to hold one or have applied for one) are able to apply to council to postpone payment of rates on their principal place of residence.

Recovery

In any case where default in payment of rates occurs, council may without further notice commence proceedings for recovery of all amounts due. Recovery options available to council include proceedings in a court of competent jurisdiction.
