Ensure the Trustee has the correct Tax File Number for the Member in order to notify the ATO of the Member leaving the Fund.</li><li>5. Notify the Member of any loss of insurance.</li><li>6. Calculate any, if applicable, pay as you go tax liability in relation to any withdrawal or transfer of superannuation benefits.</li><li>7. Pay any superannuation benefits to the account of the leaving Member choosing.</li><li>8. Notify the Commissioner of Taxation of the Member leaving the Fund through one of the following:<ul style="list-style-type: none"><li>• online at <a href="http://abr.gov.au">abr.gov.au</a> External Link;</li></ul></li></ol>

### **Trustee Binding Resolution**


