



- 2.3 For the avoidance of doubt, and to the maximum extent possible under the law any provision within the *Trustee Act 1893* (NT) that gives the Bare Trustee a right of indemnity has no application to the bare trust relationship as between the Bare Trustee and the RSF Trustee with respect to the Underlying Property.

3. Apparent purchaser provisions

- 3.1 Both the Bare Trustee and the RSF Trustee declare and acknowledge that the real purchaser of the Underlying Property is the RSF Trustee.
- 3.2 For the avoidance of doubt, the Bare Trustee and the RSF Trustee acknowledge and believe that item 6(b) of Schedule 2 of the Stamp Duty Act (NT) will apply when the legal title of the Underlying Property is conveyed from the Bare Trustee to the RSF Trustee.
