

### 1 Interpretation


- (a) Unless otherwise defined in this Deed, words and expressions defined in the Trust Deed and Rules have the same meanings in this Deed.

### 3 Appointment

#### 3.1 Appointment by Old Trustee

#### 3.3 Covenants

The Old Trustee covenants with the New Trustee to do everything necessary or desirable to vest the assets of the Fund in the New Trustee.

#### 3.4 Undertaking by New Trustee

The New Trustee undertakes to the Old Trustee and to the members of the Fund to be bound by all the covenants on the part of the trustee under the Trust Deed and Rules on and from the Effective Date.

#### 3.5 Release of Old Trustee

From the Effective Date, the Old Trustee is released from all further obligations under the Trust Deed and Rules, except in relation to:

- (a) any antecedent neglect by or default of the Old Trustee; or
- (b) any failure by the Old Trustee to vest the assets of the Fund in the New Trustee.

**3.6 Old Trustee's indemnity**

The New Trustee indemnifies, to the extent to which it can be satisfied out of property of the Fund out of which the New Trustee is actually indemnified for the liability, the Old Trustee from the Effective Date for all claims, costs (including legal costs on a full indemnity basis), damages, expenses and liabilities of the Old Trustee in respect of which the Old Trustee would have had a right of indemnity out of the assets of the Fund prior to the Effective Date.

**3.7 New Trustee's indemnity**

In relation to the Fund, the Old Trustee agrees to indemnify the New Trustee for any liability arising out of the performance of the Old Trustee's duties and obligations in relation to the Fund prior to the Effective Date to the extent that the Old Trustee would not have had a right of indemnity out of the assets of the Fund in respect of those liabilities.

**3.8 No declaration of trust**

Nothing expressly or impliedly contained in this Deed is effective to confirm, declare or otherwise acknowledge any of the trusts declared under the Trust Deed and Rules or any of the trusts to which property is subject at the date of this Deed, or to impress any new or additional trusts upon property held on trust as at the date of this Deed.

**3.9 Costs**

Each party will bear its own costs in relation to the preparation, negotiation and execution of this Deed. The Fund will bear all stamp duty payable on this Deed.

**3.10 Successors and assigns**

This Deed binds each party's successors and assigns.
