# RN & CB Rose Fund Projected Investment Strategy

#### Overview

The aim of this strategy is to provide the Members with a retirement income supplementary to their CSS pensions.

#### **Investment Objectives**

The Trustees will at all times ensure the Funds assets are invested in accordance with the trust deed and comply with the applicable legislative requirements.

The Trustees will act prudently to maximise the rate of return, subject to acceptable risk parameters whilst maintaining an appropriate diversification across a broad range of assets whilst assessing the risks where it is determined the fund's portfolio lacks diversification and / or has elected to implement a sector bias.

Having considered the risk profile of the fund and the member's needs and circumstances, the trustee has adopted the following objectives for the investment of assets of the fund:

- to achieve an investment return (based on market values and net of tax and charges) that exceeds the CPI by at least 5% per annum when measured over a rolling 5 year period.
- to have a probability of near zero or negative returns in any 12 Month period of less than one in five years; and
- have sufficient liquidity to meet liabilities as and when they fall due.
- to consider the need to hold a policy of insurance for one or more members of the fund.

#### **Investment Strategy**

The fund will invest in a portfolio of assets according to market conditions and within the ranges specified below:

#### **Asset Allocation**

The targeted asset allocation will be in the following ranges:

Quality companies and trusts as supported by research and fundamental analysis will be selected.

Both members have substantial CSS pensions. That means that there are no tight requirements for diversification in this fund. The Fund's assets can be allocated largely to direct share holdings, where returns are likely to be substantially higher than in fixed interest securities.

Emphasis on Australian shares reflects the considerable diversity available from the Australian market, including the opportunity for indirect investment in international shares through Australian EFTs. The option of direct investment in international shares is left open to allow uptake of potentially profitable opportunities.

A relatively high upper bound is set for cash to allow for short term transactional reserves depending on share market conditions and opportunities. Cash will normally be at the lower end of the range. Similarly, there may be market circumstances in which fixed interest securities to serve a short term purpose.

Liquidity is high even if the Fund's assets are fully invested in shares. It takes less than a week to convert shares to cash and the Fund's annual pension requirements and administrative costs are less than 4% of assets.

The two members share ownership of a house of substantial value. Therefore investment by the Fund in direct property would be inappropriate on diversification grounds. The option is left open for investment in listed commercial property where profitable opportunities occur.

Mortgages and other assets are excluded on the basis that neither Trustee has relevant market expertise and interest, thus making it likely that risks and search costs would be unnecessarily high.

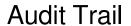
