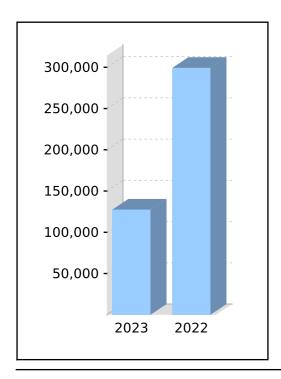

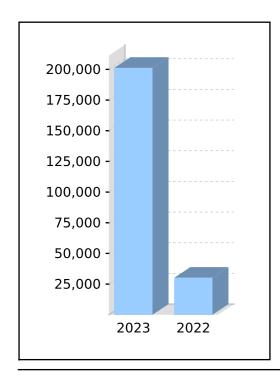

Dear Emma,

#### Re: Family Law Matter

I refer to our telephone call this morning in relation to the superannuation splitting orders.

I confirm that Ms Kelly Wu of PDK Financial is undertaking the superannuation split in accordance with the Final Orders.

You have requested a summary as to how the superannuation split was calculated pursuant to paragraphs 10 through to 12 of the Final Orders.

The manner in which the superannuation split was calculated is as follows:-

- 1. You have industry superannuation entitlements (outside of the SMSF) in the agreed sum of \$15,225.
- 2. Your husband has industry superannuation entitlements (outside of the SMSF) in the agreed sum of \$88,806.
- 3. The total of the parties' superannuation entitlements that sit outside of the Tarone Self Managed Superannuation Fund is \$104,031.
- 4. As at the date of preparing the Orders, there was approximately \$329,408 in member entitlements within the Tarone SMSF.

- 5. The total balance of your respective superannuation entitlements of both industry and SMSF funds is \$433,439.
- 6. 50% of that sum is \$216,719.
- 7. Pursuant to paragraph 11(a) of the Final Orders, the entirety of the balance (100%) of the Tarone SMSF is to be rolled over to you at first instance.
- 8. Pursuant to paragraph 12(a) of the Final Orders, your husband is then to have 50% of the balance in your member entitlement rolled over to him, less the sum of \$36,791.
- 9. Ms Wu will however have to undertake the above mathematical exercise on the member balances in the SMSF as at the settlement date, which would be 4 January 2024.
  - Hence, the overall figures with respect to the balances in the SMSF may vary slightly.
- 10. Your leftover entitlement within the Tarone SMSF can then be rolled out to an industry fund of your choice.

I trust the above clarifies how the split is to occur, however if either yourself or Ms Wu have any further questions, you are more than welcome to contact either myself or Mr Burrell.
