### 2 APPOINTMENT OF ADDITIONAL TRUSTEE

In exercise of the powers given to the Member under clause 9.3 of the Trust Deed and every other power enabling them, the Member hereby appoints the Additional Trustee as an additional trustee of the Fund along with the Continuing Trustee, with effect from the date of this deed.

# 3. TRUST FUND VESTED IN THE CONTINUING TRUSTEE AND THE ADDITIONAL TRUSTEE

The parties hereby agree that they will cause the assets of the Fund and all rights, benefits and provisions thereof to be vested in the Continuing Trustee and the Additional Trustee upon the trusts and with and subject to the powers and provisions contained in the Trust Deed and the Additional Trustee accepts their appointment as trustee of the Fund together with the Continuing Trustee and agrees to hold the assets of the Fund and all rights, benefits and provisions thereof together with the Continuing Trustee upon the trusts and with and subject to the powers and provisions contained in the Trust Deed.

#### ACKNOWLEDGEMENT

The Additional Trustee declares that they are not disqualified from acting as a trustee for the Fund under the Superannuation Industry (Supervision) Act 1993 and undertakes to resign as trustee for the Fund if they become disqualified.

#### RELEASE

The Retiring Trustee is released from their obligations as trustee for the Fund and from all claims and liabilities which arise against the trustees for the Fund after the date of this deed.

# Notes on disqualification
