AND PAUL SHRUBB INVESTMENTS PTY LTD ACN 153 935 776 of 11
Harriet Spearing Drive, Woonona in the State of New South Wales (**New Trustee**)

RECITALS

- A.** By previous deed, now referred to as the “Original Deed” the Shrubbs Superannuation Benefit Fund (“the Fund”) was established to provide superannuation benefits for the Member.
- B.** The Original Deed may have been amended from time to time so that the Original Deed and any duly authorised amendments shall now be referred to as the “Original Deed (as amended)”.
- C.** The operative provisions of the Original Deed (as amended) and any Rules attached to the Original Deed (as amended) shall for the purposes of this Deed be known as the “Governing Provisions” of the Fund.
- D.** The Member has the power pursuant to article 9.4 of the Governing Provisions of the Fund to remove a trustee and to appoint a new trustee.
- E.** The Trustee under the Original Deed (as amended) is Paul Shrubbs Enterprises Pty Ltd ACN 082 420 620 (“the Old Trustee”)
- F.** The Member has exercised its power to remove the Old Trustee and to appoint the New Trustee in its stead.

OPERATIVE PART

- 1.** The Member removes the Old Trustee as trustee of the Fund and appoints the New Trustee in its place.
- 2.** The New Trustee accepts its appointment as the New Trustee of the Fund and agrees to be bound by the Governing Provisions of the Fund.
