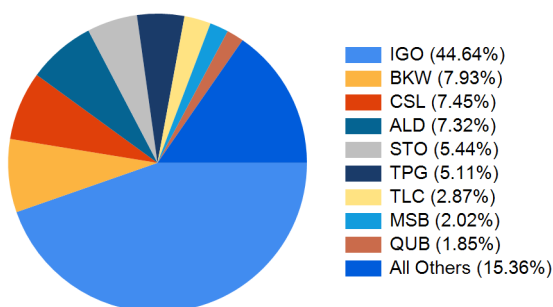

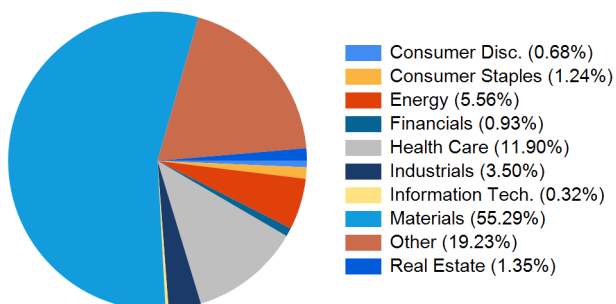

## GLOSSARY
