It was RESOLVED that:

As trustees of the PJ & LJ Superannuation Fund, we understand the compliance issues regarding the inadvertent oversight of the transfer of \$250,000.00 into a Goal Saver Account.

The Trustee went into the CBA Branch on the 20/6/23 to enquire as to the interest rate they were getting on the Accelerated Cash Account. The staff member told the Trustee 1.99% and the Trustee advised that was too low. The staff member told the Trustee they could open a Goalsaver Account, and by transferring \$1 per month into it, it would achieve a rate of 4.65%. The Trustee asked her what was required by way of paperwork and she replied nothing, they just pick up the information from the system and open it.

The staff member did not advise the Trustee that the account would be opened in his personal name, rather than the Superannuation account as per the Accelerated Cash Account – there was no mention at all of account title change.

The Trustee sent an e-mail to Goodall and Co on the 23/6/23 advising that he had transferred funds, and received a phone call back asking to confirm that there had been no change in account title.

The phone app only shows an account number, not account title holder, so the Trustee had to make an appointment at the Bank to talk with staff regarding this error and misinformation given by the banking staff member.

This was actioned on the 28/6/23, the Trustee was advised that the new Goalsaver Account was in his personal name in error, and the account was closed immediately and funds plus accrued interest deposited back into the original Accelerated Cash Account in the Super Fund name as evidenced in the attached Bank Statements.

CLOSURE:

There being no further business the meeting was declared closed.
