The Members of the Matthew Salter Family Super Fund, Matthew Salter and Lisa Salter, expect to access their superannuation from their respective preservation ages.

Asset Allocation:

The targeted asset allocation will recognises the need to have a diversified asset mix, however, given the long-term investment horizon of the members (of 20+ years until life expectancy), the allocation will have a strong growth asset bias and be focused on maximising capital growth.

The Trustee recognises the higher risk in investing predominantly in growth assets and the volatility associated with shares and property. The volatility will be compensated by the prospect of achieving higher return and growth in the longer term.

The Fund has elected to invest in unlisted shares and property. The Trustee feels this is line with the long-term investment strategy, due to the growth potential of the investments.
