No reportable contraventions of the SIS Act and/or SIS Regulations were identified during my audit.

2. Material audit adjustments

No material audit adjustments were identified during my audit.

3. Matters for trustee attention

Rollover In :

I have noticed that there was a rollover in of \$1,200.19 on 22/12/2021 for the member Andrew Robertson, however it has not been processed through Super stream. I recommend trustees to make sure that the Rollover out and in to be processed through Super stream moving forward.

Member Insurance premium:

Insurance policy number #2109 for the member Sarah Langford is not in the name of current trustee (AS & S Roberston Super pty ltd) as trustee for the super fund. Regulation 4.09A of the SIS Act requires that trustee of the fund should have title to all investments of the super fund. Trustee are advised to update the ownership details as soon as possible.
