



Dividend

Special dividend

Units The number of registered securities that you own.

Unit Price The Portfolio Valuation 'Unit Price' is calculated using a 'Reference' Price provided by the ASX which takes into account an adjustment to determine value at Close of Market if the Security does not trade in the Closing Single Price Auction on the Valuation Date. The Unit Price in the Transaction Summary is the average price paid for

each unit of stock as detailed in your contract note.

Brokerage The fee or charge that is paid by you when transacting a buy or sell. Brokerage and costs may include advice and/or service fees charged to you by your adviser

(where applicable). Refer to your adviser for further details.

When you are CHESS sponsored with a Broker you will be issued a unique number, called a HIN. Multiple holdings can be registered under the single HIN. A HIN Holder Identification Number (HIN) starts with the letter X and usually followed by 10 numbers, e.g. X0001234567.

Payment date The date on which a declared dividend is scheduled to be paid.

Unfranked dividend Dividends which do not carry a franking credit.

Franked dividends are paid to security holders out of profits on which the company has already paid tax. Franked dividend

Franking /Imputation Credit A franking credit is your share of tax paid by a company on the profits from which your dividend are paid. They are also known as Imputation Credits. Total subscriptions Total subscriptions can include, but are not limited to: MarketPro fees, Morningstar research subscription fees and trading alerts.
