### 2. Payment

Payment is due and payable within seven days of the date of the Order Form. Payments can be;

- Cash
- Visa, MasterCard, American Express or Diners (Full settlements on Amex incur a 2% surcharge)
- Bank Cheque
- Telegraphic transfer
- Personal cheque

### 3. G.S.T.

### 4. Ownership / Title of the Property

### 5. Late payment and penalties
