I direct the Trustee to pay any Death Benefits to my **legal personal representative** to be dealt with as part of my estate.


Authority to make this nomination

In accordance with clause 9.5(a) of the Fund, a member of the Fund may nominate one or more of a nominated dependant, other dependant or their legal personal representative to receive payments of their Fund benefits at death.

In accordance with clause 9.5(b) of the Fund, notice to the Trustee is to be in the form of a Death Benefit Nomination served upon the Trustee to take effect on the Member's death, which shall be a **valid binding nomination** if compliant with the Super Law.

This Death Benefit Nomination is made pursuant to the *Superannuation Industry (Supervision) Act 1993* (Cth) (the **SIS Act**) and the *Superannuation Industry (Supervision) Regulations 1994* (Cth) (the **SIS Regulations**) and the deed establishing the Fund (the **Fund Deed**).

This Nomination is made in accordance with the Commissioner's view set out in the Self Managed Superannuation Fund Determination SMSFD 2008/3 that the statutory requirements in subsection 59(1A) of the SIS Act and regulation 6.17A of the SIS Regulations have no application to self-managed superannuation funds.

This Death Benefit Nomination remains in place until and unless the nomination is later revoked by written notice from me to the Trustee, and does not lapse or expire due to the passage of time.

Binding status of this nomination

Fund means the Trustee in its capacity as trustee of the Super Fund.

Super Fund means the Ian Ford & Heather Ford Superannuation Fund.

Super Law means the SIS Act and the SIS Regulations, as amended from time to time.

Trustee means the trustee(s) of the Fund from time to time.




