RECITALS

- A. By a deed dated 1 April 2011, made by the Trustee (the "Deed"), the Glian Superannuation Fund was created (the "Fund").
- B. Pursuant to clause 18.1 of the Deed, the Trustee may at any time by deed alter, add to, replace, delete or amend any of the provisions set out in the Deed.
- C. The Trustee wishes to vary the Deed on the terms stipulated in this deed.

THIS DEED WITNESSES:

- Pursuant to clause 18.1, the Trustee hereby varies the Deed as follows:

 The Deed is amended by replacing clause 4.2 (f) with the following clause 4.2 (f):
 - **4.2 (f)** to borrow or raise any financial accommodation and to assign, pledge, mortgage or charge any of the Assets of the Fund as security for any such financial accommodation provided that such borrowing or maintenance of a borrowing does not breach the Superannuation Law;
- 2 The parties declare that:
 - a. the trusts set forth in the Deed are continuing trusts;
 - the variation is for the benefit of past, present or future members of the Fund (including their dependants);
 - c. this variation is to take effect from the date of this deed;
 - this variation does not impose any further liability on any member of the Fund; and
 - the variation does not amend the Deed in such a manner as to permit the sole or primary purpose of the Fund to be anything other than to provide old-age pensions.

Nothing in this deed reduces or adversely affects a member's right or claim to accrued benefits in the Fund or reduces an entitlement that is or may become payable in relation to a period before the date of this deed of variation.
