## ENGAGEMENT LETTER

To: Jennifer Taylor, Jenbers Superannuation Fund

### Scope

You have requested that we audit the financial report of Jenbers Superannuation Fund, which comprises the balance sheet as at 30 June 2021, and the income statement for the year then ended a summary of significant accounting policies, other explanatory notes and the trustees' declaration. We are pleased to confirm our acceptance and our understanding of this engagement by means of this letter. Our audit will be conducted with the objective of expressing an opinion on the financial report and compliance with the *Superannuation Industry Supervisory Act 1993*.




