FATCA and CRS

Australia participates in Automatic Exchange of Information (AEOI) arrangements concerning the automatic exchange of financial account information with foreign jurisdictions. These arrangements are known as the Foreign Account Tax Compliance Act (FATCA) in the case of exchange by Australia with the United States of America (U.S.) and the Common Reporting Standard (CRS) in the case of exchange by Australia with other countries that have implemented CRS.

As a result, the Trust is required to determine your country of tax residence. If you do not certify this we are required to report your name, address, amounts paid to you and value of your securities to the ATO who may report them to the Internal Revenue Service of the United States and other tax authorities.
