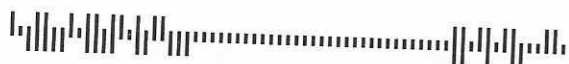

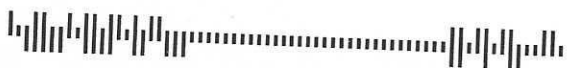
This TFN has been issued either in response to your recent application/enquiry, or at the discretion of the Commissioner of Taxation.
