You no longer need to pay your income tax by instalments

Dear Sir/Madam

We are writing to advise that from 1 January 2018 you no longer need to pay your income tax by instalments.

However, if you have already received a pay as you go (PAYG) instalment notice, you will still need to pay this, even if the due date is after 1 January 2018. If you have other obligations such as PAYG withholding and GST, you will continue to receive these activity statements.

You will need to lodge income tax returns and a credit for any existing instalments will be included in your next income tax assessment.

If you wish to continue paying instalments towards your end of year tax liability, you may voluntarily re-enter PAYG instalments by contacting the ATO on **13 28 66**. If you choose not to re-enter PAYG instalments, a change in your circumstances may require you to enter in future years. If this happens, we will let you know.

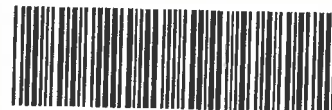
