PRESENT: Leo Bauer and Joan Bauer

PENSION CONTINUATION: Leo Bauer wishes to continue existing Account Based Pension with a commencement date of 01/07/2017. It is confirmed that the pension balance will automatically revert to Joan Bauer upon the death of the member.

The Pension Account Balance as at 01/07/2020 \$317,021.46, consisting of:

- Taxable amount of \$204,119.23; and
- Tax Free amount of \$112,902.23
- Tax Free proportion: 35.61%.

TRUSTEE ACKNOWLEDGEMENT: It was resolved that Trustee(s) have agreed to this and has taken action to ensure the following:

- The member's minimum pension payments are to be made at least annually
- An amount or percentage of the pension will not be prescribed as being left-over when the pension ceases
- The pension can be transferred only on the death of the pensioner to their beneficiary(s).
- The Trustee(s) will comply with ATO obligations such as PAYG withholding and payment summary obligations
- The fund's trust deed provides for payment of this pension to the member
- The Trustee(s) will notify the member, in writing, of their pension amount and assessable amount each year

PAYMENT: It was resolved that the trustees have agreed to pay at least the minimum pension payment for the current year of \$7,930.00 in the frequency of at least an annual payment.
