### Review and update your details online

As part of the demerger from Tabcorp Holdings Limited we have transferred across some of your details (contact details and bank account) to your new shareholding in The Lottery Corporation. As you can see, Link Market Services will also be The Lottery Corporation's share registry.

Your communication preferences have also been maintained except that you will not receive a hard copy of the Annual Report unless you notify us that you wish to receive a hard copy.

**Importantly**, as advised in the Demerger Booklet, your Tax File Number (TFN) or Australian Business Number (ABN) (if applicable) has **not** been provided to us. Instructions on how to provide these details are included in this letter.

You will need your Holder Identification Number or Securityholder Reference Number (shown above) to log in.

The Lottery Corporation proposes to pay dividends by direct credit to nominated Australian bank accounts. It currently does not offer participation in a Dividend Reinvestment Plan but may do so in the future. The Lottery Corporation anticipates that it is likely to pay its first dividend in or around March 2023. The determination of a dividend remains subject to law, business performance and all necessary Board approvals.

Whilst there is no obligation to provide a TFN, ABN or exemption, if such information is not provided we are required to withhold tax at the highest marginal tax rate on any unfranked portion of your dividend. For non-resident investors, we are required to withhold tax from any unfranked portion of your dividend.
