





FINANCIAL STATEMENTS OF SUPERANNUATION FUND:

It was resolved that the financial statements would be prepared as special purpose financial statements as, in the opinion of the trustee(s), the superannuation fund is a non-reporting entity and therefore is not required to comply with all Australian Accounting Standards.

It was resolved to ratify the investment disposals throughout the financial year ended 30 June 2021.

It was resolved that the contributions during the year be allocated to members on the


basis of the schedule provided by the principal Fund employer.


