In preparation for your examination of the special purpose financial report of the **Lyons Superannuation Fund** as at 30 June,2021, the following representations are made which are true to the best of our knowledge and belief:

1. Risk of Fraud

The risk that the financial report is materially misstated due to fraud is considered to be low as a result of the following:
