Despite the efforts of the Trustees, the changes to the ownership documentation and written confirmation of carrying values are unable to be provided at this time due to a number of factors. Therefore, as trustees, we have made our own enquiries and state the values based on a realistic appraisal of current market conditions. The trustees will continue to work towards obtaining a change in official documentation with the current Directors of these unlisted investments despite the lack of response provided by them to date. The reason for the later problem is the state of disagreement which exists between various interested parties and management of these investments.
