## **Conclusion:**

The sales of 46/328 Albany Highway at \$1,107 per sqm appears to be an abnormal sale as the sales afterwards indicates the price is around \$3,000 per sqm. Further the latest valuation by LJ Hooker made afterwards on 31 December 2020 indicates the price per sqm between \$3,793 and \$3,965.5.

Most of the offer related to offices in the building 328 Albany Highway are above \$4,500 which was higher than the valuation last year which was also higher than 31 December 2020 valuation.
