Thank you, BAS is paid and lodged on due date, you get a four week extension for lodging electronically with a tax agent.

Yes you are correct in regards to the SMSF loan, to ensure the loan is at arm lengths terms, as previously discussed repayments must be made <u>monthly</u>. I'm sorry we were waiting for the ATO to release the benchmark interest rate for the year which is 5.1%.

The loan repayments we have calculated are \$1910.43.

This amount is to be paid monthly from the SMSF to you as individuals, any date of the month which suits you. It is made up of principle and interest component. The repayment amount may change yearly due to the ATO interest rates changing so we can notify you if it does. This repayment is a <u>minimum</u> amount so if you would like to repay more that is fine.
