

1.0 Fund Policy

The Trustees of the JL & DM Superannuation Fund recognize that to obtain good investment performance and to meet administration and legal obligations of trustees, there is a need for continuing attention to investment management and the administrative and tax matters of the fund.

The Trustees require: Regular reporting and review of investment positions, up to date records of investment activity and member funds and the application of appropriate policies and procedures for managing risk.

2.0 Fund Structure

Statement for the Half Year ended 31 December 2021

• Operation:

There have been no changes to the day to day operations of the fund. The Trustees continue to monitor investment positions and markets on a daily/weekly basis and transactions are recorded, marked to market, and reported weekly.

• SMSF Value

The Holdings report for 31 December 2021 indicates a new value of \$300,759, down from \$314,323 on 30 June 2021 and \$315,755 at 31 December 2020. This reflects movements in share market values, record low interest rates and ongoing pension payments.

• Costs:

Costs of running and maintaining the Fund include the usual expenses, ranging from stationary to computers and communication access fees.

Total expenses (excluding bank, brokerage and audit fees and taxes) for the Dec/Dec 12 month period are expected to be in line with last year.

• Members:

Members remain at two. All rights and obligations of members and trustees are set out in the Trust Deed and Investment Policy and Strategy documents which have been prepared by the trustees and accepted by audit oversight. These documents are available for reference at any time.

• Investment Activity and Diversification:

Shares – Current positions are detailed in the attached Holdings report. Given the long-term requirements of the fund, an exposure to the share market is considered prudent, particularly with deposit interest rates maintaining record lows. However, with markets nearing index highs and massive global debt levels due to the pandemic, further share market investments will remain on hold.

Current investment profile - members are aged 77, very conservative (risk averse).

Current portfolio weighting – cash 81.80% (5.75%) - Fixed Interest 0.0% (77.8%) - Stocks 18.20% (14.30%).

Property - considered long term and not fully suitable.

Managed investments - suitable but as mentioned above, very uncertain.

Cash and fixed interest currently do not offer great returns but are considered relatively safe.

Stocks – Given expected increases in interest rates and particularly higher inflation, a move to an increased stock weighting and a lower cash weighting is being considered.

• Interest Bearing Investments

All term deposits have now been closed: Provident Capital has been finalized and the last term deposit redeemed for cash.

Interest rates are maintaining record low levels but are expected to increase later in 2022. In the meantime, cash amounts remain in interest bearing cash management accounts.

• Provident Capital

The last property has finally been sold and distributions have been completed. An update from the Provident Capital Receivers in June 2021 included a small final distribution and advised that no further proceeds are expected.

• Compliance with Policy and Strategy

Investments and activity continue to comply with policy, strategy, and relevant legislation requirements.

Statement for the Half Year ended 30 June 2022

• Operation:

There have been no changes to the day-to-day operations of the fund. The Trustees continue to monitor investment positions and markets on a daily/weekly basis and transactions are recorded, marked to market, and reported weekly.

• Covid 19:

The half year to June 30 has seen Covid control issues steadily removed with current wisdom that people should learn to live with the virus rather than aiming to eradicate it. Nevertheless, infection rates, hospitalisations and mortality, remain stubbornly high.

High government debt and squeezed global economies are likely to have severe impacts for years to come.

Social impacts resulting from school closures, household and community lockdowns, as well as the experimental vaccines being employed, are likely to have long term impacts not currently envisaged.

Equities and financial markets have been resilient, holding steady market values until the April/June quarter, when inflation reared its head. This has necessitated stiff interest rate increases to regain control. No one can say where this will end.

• Earnings

The Holdings report for 30 June 2022 indicates a new value of \$263,902, down from \$300,759 on 30 December 2021 and down from \$314,323 at June 2021. This result reflects low interest rates, a sudden drop in share prices and pension payouts over the period.

• Costs:

Costs of running and maintaining the Fund include the usual expenses, ranging from stationary to computers and communication access fees.

Total expenses (excluding bank, brokerage and audit fees and taxes) for the Dec/Dec 12 month period were \$1645.27, down from \$1755.40 for the corresponding period last year. The slightly lower cost is a result of lower technology related expenses.

• Members:

Members remain at two. All rights and obligations of members and trustees are set out in the Trust Deed and Investment Policy and Strategy documents which have been prepared by the trustees and are available for reference at any time.

Investment Activity and Diversification:

Shares – Current positions are detailed in the attached Holdings report. Share market prices had a good recovery after the 2020 Corona low but rising inflation and interest rates in the April/June quarter this year has prompted another sell-off.

World and Australian debt levels, a major issue before the pandemic, are much worse now and still climbing.

Political instability, involving China's aggressive attitude to Taiwan and in the Indo Pacific, Russia's invasion of Ukraine and very recent build-up of NATO actions, are keeping confidence restrained.

Only one share position has been maintained while markets are so uncertain. Rising interest rates will eventually attract term depositors and low share prices will attract some to re-enter the equities and other markets, aiming to help savings to keep pace with inflation.

Current Investment profile - members are aged 77 - very conservative (risk averse).

Current portfolio weighting – cash 81.7% - Fixed Interest 0.0% - Stocks 18.3%. Property - considered long term and not fully suitable.

Managed investments – markets very uncertain but must soon be considered to maintain value against rising inflation, regardless of some risk.

Cash and fixed interest currently do not offer great returns but rising inflation and interest rates could become attractive in the medium term.

Interest Bearing Investments

The last Term Deposit was closed during the year, looking for a place in the equity market.

Interest rates remained at historically low levels of 0.01% with the Reserve Bank indicating no change until 2024. This idea could not be maintained when inflation took hold, reaching over 5% in April. In the meantime, cash amounts remain in interest bearing cash management accounts.

• Provident Capital

The previously held position was closed in June 2021 when Provident was effectively wound-up.

• Compliance with Policy and Strategy

Current positions and ongoing account and maintenance activity remain within strategy and policy requirements.
