## DEED OF CONFIRMATION OF APPOINTMENT OF TRUSTEES

THIS DEED OF CONFIRMATION OF APPOINTMENT OF TRUSTEES is made on the day specified in Item 1 of the Schedule between the Continuing Trustees named and described at item 4 of the Schedule ("the Continuing Trustees"), the Members named and described at item 5 of the Schedule ("the Members") and the Additional Trustees named and described at item 6 of the Schedule ("the Additional Trustees").

# 1. CONFIRMATION OF APPOINTMENT OF ADDITIONAL TRUSTEES

In exercise of the powers given to the Members under clause 9.3 of the Trust Deed and every other power enabling them, the Members hereby confirm the appointment of the Additional Trustees as trustees of the Fund together with the Continuing Trustees, with effect from the appointment date.

The Additional Trustees declare that they are not disqualified from acting as trustees for the Fund under the Superannuation Industry (Supervision) Act 1993 and undertake to resign as trustees for the Fund if they become disqualified.
