Information on Licence Renewal Process

Your Taxi Service/Limousine/Special Purpose Limousine Licence is now due for renewal. Please complete the attached renewal application and submit it at your nearest Department of Transport and Main Roads (TMR) Customer Service Centre with the appropriate fee.

Under the *Transport Operations (Passenger Transport) Act 1994*, Taxi Service and Limousine Licences are issued for a 5-year period (except Special Purpose Limousines). However, you can elect to renew your Taxi Service or Limousine Licence for a shorter term. You will need to indicate the number of years that you wish to renew your licence on the renewal application.

Please note that if a Special Purpose Limousine Licence is expired for more than three months, it cannot be renewed. In order to retain your Special Purpose Limousine Licence, you will need to ensure that you renew the licence and pay the fee before the expiry date.
