- (3) "Effective Date" means the date of execution of this deed.

62966.62977 Interpretation

In this Deed unless the context otherwise requires:

- (1) the singular includes the plural and vice versa;
- (2) the use of one gender includes all other genders;
- (3) representations, agreements, covenants, obligations or warranties, express or implied, by more than one person includes those persons jointly and each of them severally;
- (4) every provision, express or implied, which applies to more than one person applies to those persons jointly and each of them severally; and
- (5) person means and includes a natural person, firm or corporation.

62966.62978 Headings

Headings in this Deed, other than headings in the Schedule (if any), are for reference purposes only and are not intended to affect the interpretation of this Deed.

62966.62979 Laws of Western Australia

This Deed is governed by reference to the law of Western Australia.

62966.62980 Introduction

The paragraphs referred to in the introduction to this Deed are incorporated in and form part of this Deed.

62966.62981 Severance

If any provision or part of a provision of this Deed is or becomes void, invalid or unenforceable for any reason then that provision or part will be severed from this Deed but the remainder of this Deed will continue in full force and effect.

62966.62982 Meanings

Unless the context otherwise requires, any word or phrase used in this Deed which is not defined but which is defined in the Trust Deed has the same meaning as contained in the Trust Deed.

62967, APPOINTMENT

- 2.1 The Trustees agree to appoint the Additional Trustee.
- 2.2 The Additional Trustee by its execution declares its acceptance of the appointment referred to in clause 2.1.
- 2.3 The appointment is to take effect on the Effective Date.
- 2.4 The Additional Trustee agrees to accept the appointment as one of the trustees of the Fund in accordance with the terms and conditions of the Fund set out in the Trust Deed and rules.

 - (1) The Additional Trustee is appointed as a consequence of the Additional Trustee applying to be a member of the Fund and that application being accepted;
