Minutes

Amending Current Deed and Rules (Where current document limits amendment)

In some cases, the current Deed and or Rules of the Fund proposed to be updated may contain provisions which prevent the adoption of new rules in certain circumstances such as where the proposed new rules allow for the appointment of individuals as trustees of the Fund.

If this is the case with this Fund, the situation should be rectified before the enclosed Amended Rules are adopted. If at the same time, it is proposed to appoint a new Trustee or Trustees of the Fund, it is desirable that the current Trustee of the Fund should resolve to amend the Deed and Rules.

To assist, a pro-forma minute of amendment is enclosed. NOTE: this may not be suitable in all cases and if you are uncertain as to whether or not it is appropriate, specific advice should be sought.

NOTES:

Modified Superannuation Fund Rules

- 1. The Rules comply with the Superannuation Industry (Supervision) Act 1993 and the Superannuation Industry (Supervision) Regulations 1994 ("SIS") as amended, and are intended to replace the existing Rules of a Superannuation Fund.
- 2. The Rules are intended to be adopted by Deed of Variation (enclosed).
- 4. Under SIS, funds with not more than 4 members may be Self Managed Funds which are not subject to as many restrictions as apply to Funds with 5 or more members.
- 3. The deed and rules have been drawn so as to be appropriate for:

Self Managed Funds, Self-Employed Persons Funds, Single Member Funds, and 5 or More Member Funds.

- 5. Contributions may be made by anyone allowed by law to do so and may be made by one party on behalf of another, eg Employer or Spouse contributions.
- 6. The Rules allow for different classes of members, and for employers to make contributions at different rates for the different classes.
- 7. Records Trustees are required to keep records for 10 years. Records include minutes of Trustee meetings, records of changes of Trustee, and copies of reports given to members.
- 8. The Fund's accounts must be audited and an annual report lodged with the ATO.
- 9. If the Fund is a Self Managed Fund, the Trustee must give each member a statement that "this Fund is not subject to detailed prudential supervision".
- 10. SIS prohibits loans to members or relatives; imposes severe restrictions on Trustees' power to borrow money; places strict limits on a fund owning "in house assets"; prohibits investments which are not made at arm's length and places restrictions on payments to an employer-sponsor. This is not a complete list of the restrictions imposed by the Relevant Law, which includes SIS and the Tax Act.
