Investment Strategy for Financial Year 2021 to 2022 as at 30 June 2021

Background

The Trustees of the fund have devised this Investment Strategy for the fund considering the objective of the fund and in line with the governing rules of the fund and superannuation law. Through this investment strategy, the trustees are seeking to maximise the superannuation benefits for its members of the fund having regard to risk and reward of each type of investment.

Among other things, the Trustees have considered and determined that the funds current asset mix of assets is appropriate for its members for the financial year. The Trustees have given regard to the members' ages and the inability of two members to withdraw from the fund their superannuation interests for retirement purposes and the ability of two members to withdraw from the fund for retirement pension purposes in devising the strategy for the next financial year.

Leonard Waddell is 75 years of age and has reached his preservation age. Is currently drawing a pension from the fund. His fund balance on 30 June 2021 is \$1,835,106 and he has ceased working.

Lesley Waddell is 74 years of age and has reached her preservation age. Is currently drawing a pension from the fund. Her fund balance on 30 June 2021 is \$1,797,216 and she has ceased working.

Vanessa Waddell is 49 years of age and has not reached her preservation age which is 60. Her fund balance on 30 June 2021 is \$308,445 and she is still currently working.

Claire Waddell is 46 years of age and has not reached her preservation age which is 60. Her fund balance on 30 June 2021 is \$143,802 and she is still currently working.

Investment Objectives

To maximise returns and minimise risks of investment of the fund's assets in managing and providing superannuation benefits to the members of the fund.

To ensure funds are available to pay the pensions without any forced asset sales.

To ensure all investments are consistent with the governing rules of the fund and appropriate Superannuation Legislation and the fund's investment strategy.

Risk and Return on Investments

Each investment will be made with due regard to the associated risk and expected return. The Trustees seek financial advice on a regular & frequent occasions when required and both pension members have investment experience.

To maximise overall returns of the fund's investments and minimise the exposure of risk from any particular investment, the fund will try to maintain a diversified portfolio.

The Trustees have maintained a high level of cash balance in the fund due to the unknown impact over the long term of the Covid-19.

Asset Class

The fund's asset classes as at the close of the year (30 June 2021) are as per the attached Strategy Minute.

Insurance Cover

The Trustees will assess the need for life insurance for the members and will seek financial advice if required, at least annually to review any future life insurance.

Review

The investment strategy will be reviewed regularly and at least once a year at the end of each financial year.

The investment strategy may be revised as appropriate where the trustee's investment objectives change or to include a particular class or type of investment. The fund's investment portfolio is constantly under review.

- (iii) The risk involved in making, holding and realising, and the likely return from, the Fund's investments having regard to its objectives and its expected cash flow requirements. Risks involved include market risk, operational risk, liquidity risk, and credit risk.
- (iv) The composition of the Fund's investments as a whole including the extent to which the investments are diverse or involve the entity in being exposed to risks from inadequate diversification.
- (v) The liquidity of the Fund's investments having regard to its expected cash inflows, and cash outflow requirements. Items considered included the required amount of investment in cash or in assets readily convertible into cash, the expected timing of investment income and member contributions, and the expected timing of expenditure such as tax and member benefit payments.
- (vi) The ability of the entity to discharge its existing and prospective liabilities.

It was noted that the Fund's investment strategy defined the minimum and maximum allocations to the various asset classes as follows:


