The 2021 annual fee required by ASIC is \$55.00. Please note that this amount is not subject to GST and is payable by the due date 27 June 2021.

Please also note that heavy penalties will be imposed by ASIC if the Company Statement is not lodged by the due date. A late fee of \$80.00 for payments up to one month late can be charged, increasing to a maximum of \$333.00 if over one month late. Please ensure payment is made on or before the due date as ASIC are currently striking off companies that do not pay on time.

DIRECTOR IDENTIFICATION NUMBER (DIN)

The DIN regime will shortly become operational. The legislation is intended to lessen corporate phoenix activity; under the scheme directors will be required to have their identity verified and have a unique and permanent identifier issued to them.

Companies will need to put processes in place to ensure that all existing directors apply for a DIN within the prescribed timeframe. Also, companies will need to ensure that director appointment processes include the necessary steps for new directors to apply for a DIN. The number will continue to apply even if a director leaves their position.

The legislation introduced both civil and criminal penalties for a failure to apply for a DIN within the required time frame, with criminal penalties for deliberately providing false identity information or false DIN to a government body and intentionally applying for multiple DINs.

The procedures and documents required to obtain a DIN are not yet available. We will advise you of the actions required once they are issued and known.

We also enclose our Memorandum of Fees. Would you please arrange the payment of our fees and return the signed resolution to our office at your earliest convenience.
