



The funds will be used to grow our business development team and develop a marketing strategy with the primary purpose of increasing contracted recurring revenue and delivering value for shareholders and customers alike.



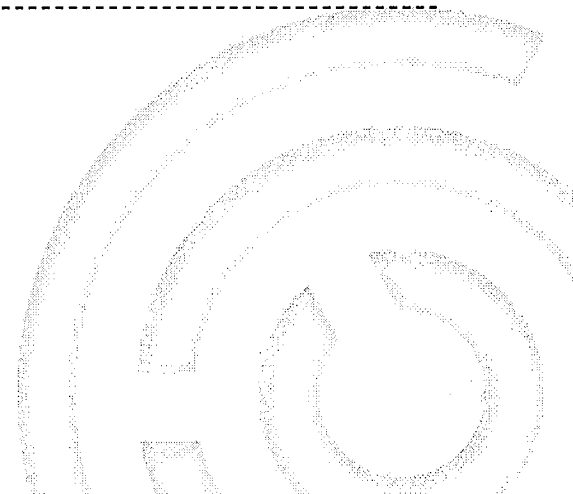
