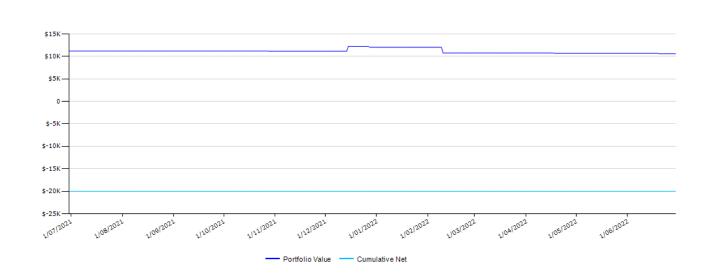

### Portfolio Value versus Cumulative Net Investment



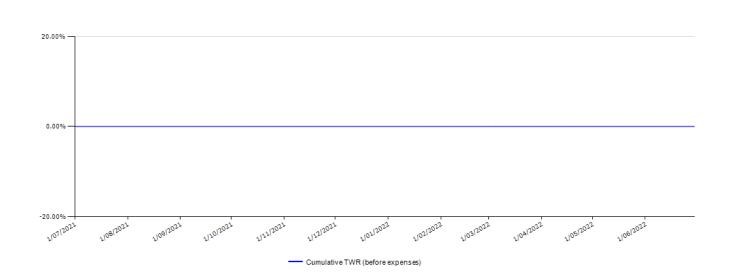

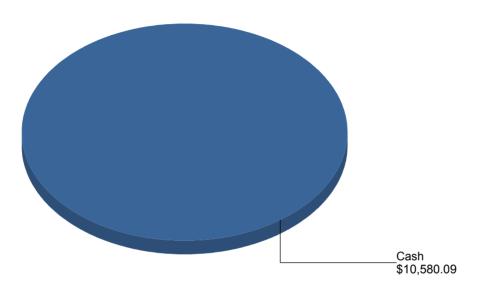
