

Electronic Lodgment Declaration (SMSF)





ENGAGEMENT LETTER

Scope

You have requested that we audit the financial report of IS2 Superannuation Fund, which comprises the balance sheet as at 30 June 2021, and the income statement for the year then ended a summary of significant accounting policies, other explanatory notes and the trustees' declaration. We are pleased to confirm our acceptance and our understanding of this engagement by means of this letter. We look forward to your full cooperation and make available to us whatever records, documentation and other information we request in connection with our audit.


