2.3 Inconsistency

For the avoidance of doubt, if any provision of this Deed conflicts or is inconsistent with any other provision or clause of the Superannuation Deed, then the provisions of this Deed to the extent of the inconsistency, will prevail.

2.4 Governing Law

This Deed shall be governed by and construed in accordance with the laws in force in South Australia and the parties agree to submit to the jurisdiction of the Courts of that State and of all courts competent to hear appeals from those Courts in relation to any legal action, suit or proceeding arising out of or with respect to this Deed.

2.5 Counterparts

This Deed may be executed in any number of counterparts each of which is an original and all of which constitute one and the same instrument. A facsimile copy of this Deed constitutes a "counterpart" for the purposes of this clause.

2.6 Definitions and Interpretation
