Fee cap for low-balance accounts

If your account balance is less than \$6,000 at the end of the fund's income year or on the date your account closes, certain fees and costs charged to you in relation to administration and investment will be capped at 3% pa of your account balance. Any amount you pay above this cap must be refunded.

Taxes and tax benefit

A tax benefit may apply to fees charged to your super account. All fees shown in 'Fees deducted directly from your account' in the 'Fees and costs summary' section are before any tax benefit. We charge the fees shown and then pass the tax benefit back to your super account as a credit, which effectively reduces the fees shown by up to 15% pa. In addition, Reduced Tax Income Credits (RITC) may also be applicable on some of the fees and any benefit will be displayed in the 'Your Transaction List' section.

All fees and charges (except investment manager fees) are paid out of your Plan account.
