

MEMORANDUM OF RESOLUTIONS OF THE TRUSTEES,

INVESTMENT STRATEGY FOR YEAR ENDED 30TH JUNE 2021.

THE TRUSTEES REVIEWED AND DISCUSSED THE EXISTING INVESTMENT STRATEGY, CONSIDERING THE FUNDS PERFORMANCE AS WELL AS ITS OBJECTIVES AND CASH FLOW REQUIREMENTS.

- 2) THE AGE AND HEALTH OF THE MEMBERS AND THE POSSIBILITY OF A CLAIM IN THE NEXT 5 YEARS WHERE LIQUIDITY OF THE FUNDS INVESTMENTS WOULD BE IMPORTANT.

THAT A PREDOMINANTLY CASH PORTFOLIO WOULD CONTINUE TO BE PURSUED WITH DIVERSIFICATION ACHIEVED BY HOLDING A PERCENTAGE OF FUNDS IN CASH IN SEVERAL BANK ACCOUNTS AND WITH THE LARGEST PERCENTAGE OF FUNDS INVESTED IN VARIOUS TERM DEPOSITS TO MATURE ON DIFFERENT DATES SPREAD BETWEEN DIFFERENT BANKS.

IT WAS ALSO DECIDED TO MAINTAIN A MINIMUM EXPOSURE TO DOMESTIC SHARES.
